





CA18238 Ocean4Biotech 2nd Call for Inclusive Target Country Conference Grant Applications for conferences occurring from 1st of September to 20th of October 2023

Call Deadline 20th September 2023, 23:00 h CET.

This call is open for all conferences occurring between 1st of September to 20th of October with special emphasis on VI Scientific and Practical Conference of Young Scientists "Modern Hydroecology: The Role of Scientific Research in Addressing Current Issues" occurring from 10th to 11th of October 2023 in Ukraine.

Inclusive Target Country (ITC) Conference

ITC Conference consists in a presentation of the own work given by a Young Researcher and Innovator¹ affiliated in an ITCs / Near Neighbour Country (NNC) for their participation in high-level conferences fully organized by a third party, i.e. not organized nor co-organized by the COST Action.

ITC Conference:

- Serve COST Excellence and Inclusiveness Policy;
- Support Young Researchers and Innovators affiliated in a legal entity in an ITCs / Near Neighbour Countries to establish a strong network and increase their visibility in the research community through sharing their work and to gain knowledge;
- Can contribute to increasing visibility of the Action.

Funding conditions apply:

- up to a maximum of EUR 2 000 for face to face conferences and EUR 500 to online conference will be granted to each successful ITC conference grant applicant;
- ITC conference must occur entirely within the dates specified for this call.
- Contribution should be in line with Ocean4Biotech objectives, which can be found here (page 10-11).

How to apply for ITC conference grant

- 1. All applicants must register for an e-COST profile at https://e-services.cost.eu/ adding their bank account details to their profile.
- 2. Applicants must submit their ITC conference grant applications online at the following web address: https://e-services.cost.eu/activity/grants
- 3. Information to be filled in e-COST:
 - Title of the presentation.
 - Conference title, date and country.
 - Budget requested.
 - Attendance Type (face to face or virtual).
- 4. Documents to be uploaded to e-COST:

- Application form (template available on e-COST) describing: Relevance of the conference topic to the Action and Motivation describing the potential for impact on the applicant's career.
- Copy of the abstract of the accepted oral or poster presentation;
- Acceptance (or invitation) letter from the conference organisers.
- 5. The formally delegated ITC grants committee will then assess the applications. Committee is composed of Dragana Drakulovic (Montenegro), Danijela Joksimovic (Montenegro), Johan Robbens (Belgium) and Orhan Tufan Eroldogan (Turkey). - 6. The applicant will be formally notified of the outcome of their ITC conference grant application by **30**th **September 2023**.
- 7. Until 25 October 2023 ITC conference grantees must submit following documents:
 - Report to the Action MC on the outcome of the presentation of the accepted contribution, in terms of grantee's visibility, including the establishment of new contacts for future collaborations.
 - The certificate of attendance.
 - The programme of the conference or book of abstracts / proceedings indicating the oral presentation of the grantee.
 - Copy of the given presentation (oral or poster).
